Market and feasibility studies

What will you get out of an investment? Wipfli offers market, marketability and feasibility studies to determine if an investment is worth your while. A market study typically evaluates factors that influence the supply and demand for real estate in a particular market. It's often paired with a marketability study, which evaluates how these factors affect the development potential of a specific site or building. The result lets you identify the potential market and investment risks.

Both studies culminate in a feasibility study, which determines whether the expected returns on a particular project justify the market risk.

Date of death appraisals provide supportable conclusions of value and take into consideration the terms of any existing buy/sell agreements. For determining applicable discounts, there is a sound framework for valuation, but the courts are beginning to scrutinize the process. Recently, the IRS has focused on 1) whether a family-limited partnership (FLP) or trust has a "business purpose" or is merely a tax dodge and 2) whether or not the valuation is accurate.
